RULES AND REGULATIONS

A. MEMBERSHIP REQUIREMENTS:

- 1. Only those whose trading history and interests match our trading room and add value to the community will be considered for Membership at TradeTheMarkets Live Trading Room. Applicants who have minimal trading experience and/or are new to trading may be put on a Waitlist. We may recommend these applicants watch our Market Internals CD-ROM and then pass a test before Membership is finalized.
- 2. Memberships at TradeTheMarkets Live Trading Room are currently on a monthly basis, however, TradeTheMarkets reserves the right to create additional types of membership:
 - a. Month by Month Membership – Membership is at a month by month basis. You will be charged \$295 / Month. You can cancel any time before your next billing date. There are no refunds for any reason.
- 3. In order to access the Live Trading Room, you must sign up for Hotcomm Lite. The Hotcomm Lite fee is NOT included in the TradeTheMarkets Live Trading Room membership fee. They are a separate company and their prices are listed on <http://www.hotcomm.com/products.asp#lite>.

If rejected, the Membership will be cancelled and contract terminated.
